## **DISTRICT BOOT HIKE & 80th CELEBRATIONS**

Dear Parents and scouts

#### BOOT HIKE

The annual District Boot Hike will be taking place on Malonjeni farm close to Suikerbosrand on Friday 18 July 2008. The scouts will meet at St Benedict's College at 18h45 on 18 July and will be back at the College at 07h30 on the 19<sup>th</sup>. As always, the scouts will travel in full uniform. The cost of the event is R60,00 per scout, which includes camping fees and transport to the venue, but which excludes food. There will be no scouts for those not attending the hike.

District requires detailed entry forms to be submitted by Monday. As such, please rely to the event by no later than Sunday 13 July 2008. Regrettably we only received details of the hike this week, and could not call for entries before this.

Each patrol needs to bring a STA kit, 2 sets of 2x AAA batteries (a basic GPS will be provided), a basic first aid kit and anything else that they feel will help them on the hike.

Individuals should bring a warm change of clothing, a water bottle, a warm sleeping bag, a torch, hiking boots, personal medication, a duly completed consent form and snacks. Scouts may leave their kit at base camp, but it is suggested that a light day pack be brought to contain your snacks and the patrol equipment. Scouts may bring additional equipment that they may feel is necessary.

Friends of scout-going age may attend the event provided that they have the relevant consent forms etc and have replied on time. Patrols consist of between 5 and 8 members. Patrols who have too few members to enter a full patrol should advise me so that a mixed patrol can be created. Patrols will be finalised on Monday evening at the Court of Honour.

Many individuals are taking "chances" with their consent forms. Your parents or legal guardians must sign the form. Scouts are big and ugly enough to fill out their details on the form to avoid this being a major chore for parents. NO CONSENT FORM, NO GO.

If you have any queries or concerns, please don't hesitate to contact me or your patrol leaders.

### 80<sup>TH</sup> CELEBRATIONS

On 26 July 2008 the Troop will be turning 80.
